Requirements for Project UnAbashed

- Dance must indirectly or directly bring glory to Jesus Christ
(Dance does not need to be overtly "Christian", we welcome creativity, and aspire for excellence with artistry in dance technique, but never at the cost forsaking what God upholds to be pure and righteous.)
- Dance should be no longer than 5 minutes for a solo, 10 minutes for group piece
- All participants must be available all day Sunday August 16th, which will include check-in, a time of worship and prayer, one class together, dress rehearsal at the theater, and the performance at the Eichelberger Theater for the Performing Arts. 9:00am-10:00pm
- **\$45.00 submission fee**: includes 1 dance class, 2 show tickets, and presentation of your choreography
- Each additional dancer pays \$20, which includes 1 dance class and rehearsal at theater
- Submit video/dvd/email/live presentation of completed dance by July 1st.
